MINUTES OF THE FISCAL COUNCIL'S MEETING
HELD ON FEBRUARY 27, 2019

I. Date, Time and Place: February 27, 2019, at 9:00 a.m., at Gol Linhas Aéreas Inteligentes S.A. ("Company"), Praça Comte. Linneu Gomes, S/N, Portaria 3 - Prédio 7 - Meeting Room of the Board of Directors, Jardim Aeroporto, City and State of São Paulo.

II. Calling: Call Notice on August 16, 2018.

III. Attendance: All members of the Company's Fiscal Council, Ms. Marcela de Paiva and Messrs. Marcelo Curti and Marcelo Moraes. Renata Bandeira Gomes do Nascimento, Mônica Gomide Mendes, Marcela Chaves Simões Palma and Mr. Fabio Pereira Teixeira also participated as guests. Mrs. Vanessa Martins Bernardi (partner) and Luiz Gehlen (manager), representing Ernst & Young Auditores Independentes S.S., as external auditors of the Company ("EY"), were also present.

IV. Presiding Board: Mr. Marcelo Moraes was the chairman of the meeting, and invited me, Marcela Chaves Simões Palma, to act as secretary of the meeting.

V. Agenda: To analyze: **(i)** the presentation of the main topics discussed with EY regarding the fourth quarter of 2018; **(ii)** the Company's financial statements for the fiscal year ended December 31, 2018 and the Annual Management Report; and **(iii)** EY's formal communications as external auditor of the Company ("Formal Communications").

VI. Presentations: Mrs. Renata Bandeira presented topics (i) and (ii) of the agenda and provided clarifications and explanations regarding matters and questions raised by those present in the meeting. Finally, Ms. Vanessa Martins Bernardi, representative of EY, presented the Formal Communications, informing that no relevant adjustments were identified during EY's audit work for the fiscal year ended December 31, 2018.

Resolutions: After the necessary explanations were provided and after a detailed review of the documents regarding the matters hereof, the following resolutions were approved by unanimous vote:

"The Fiscal Council of Gol Linhas Aéreas Inteligentes S.A., in the exercise of its legal and statutory duties, examined the Management Report, Balance Sheet, Statement of Income, Statement of Comprehensive Income, Statement of Cash Flows, Statement of Changes in Stockholders' Equity, the Statement of Added Value and the respective individual and consolidated Notes to the Financial Statements for the fiscal year ended December 31, 2018, accompanied by the opinion of the External Auditors, and agree that these reports adequately reflect the Company's economic and financial position as of December 31, 2018 and are in proper condition to be approved by the Annual General Shareholders' Meeting."

VII. Suspension of the Meeting and Drawing-up of the Minutes: These minutes were read, checked and signed by the attendees.
